The Honorable Judge Silveira,

This letter is in response to the final report from the Civil Grand Jury dated June 17, 2015 regarding the above mentioned Civil Grand Jury Case. The report made one recommendation to the City of Oakdale regarding the four foot fence surrounding the airport entrance areas. The recommendation was to raise the height of the fencing. The City of Oakdale agrees with this recommendation.

Our Airport Capital Improvement Program has included perimeter security fencing in this fiscal year's budget. Raising the fence height at the entrance will be a part of the overall security fencing project. However, the completion of the security fencing has been delayed because of an FAA requirement to perform a Wildlife Hazard Assessment prior to the fencing project. Estimated completion of the \$400,000 security fencing project will be summer of 2016.

The City of Oakdale appreciates the input on our airport by the Civil Grand Jury. If I may be of any other assistance to the Civil Grand Jury regarding the Oakdale Airport, Case 15-03C, please feel free to contact me at your convenience.
