On April 6, 2020, the Judicial Council of California adopted Emergency Rule 4 requiring each superior court to adopt a Statewide Emergency Bail Schedule to provide uniformity in the handling of certain offenses during the state of emergency related to the COVID-19 pandemic.

In compliance with Emergency Rule 4, Stanislaus County Superior Court adopted the Statewide Emergency Bail Schedule. Among other things, the Emergency Bail Schedule requires that bail for all misdemeanor and felony offenses be set at \$0, with the exception of only those offenses identified in Emergency Rule 4(c)(1)-(13).

GENERAL ORDER RE

APPLICATION OF EMERGENCY BAIL SCHEDULE RULE 4 - \$0 BAIL

1 The Court reviewed Stanislaus County Sheriff's "Who's In Jail" report as of April 10,
2 2020. The report listed each individual accused of a crime and held in pretrial custody at the
3 Stanislaus County Jail. The Court then issued General Order No. 2020-009, with a list of
4 defendants eligible for \$0 bail attached (Attachment A).
5

6 Based on a subsequent review of Attachment A to General Order No. 2020-009, the
7 Court finds it included individuals who did not qualify for \$0 bail due to their status as
8 sentenced, or being subject to pending competency proceedings. The Court finds those
9 individuals should be removed from the list of persons who qualify for \$0 bail.

11 Therefore, the Court finds that only a defendant listed in Attachment A (Rev. 4/14/20) to
12 this Order qualifies to have bail in their case set at \$0. This finding only applies to the cases
13 listed on Attachment A (Rev. 4/14/20) and does not apply to any other case(s) for which the
14 defendant is in pretrial custody.

16 IT IS THEREFORE ORDERED that the bail for each individual listed in Attachment A
17 (Rev. 4/14/20) be set at \$0 effective immediately.

18 This order rescinds and supersedes General Order No. 2020-009, issued on April 13,
19 2020.

21 This order is effective immediately and shall remain in effect until modified or rescinded
22 by order of this court, or until terminated, amended, or repealed by operation of Emergency Rule
23 4(g).
