CONTINUED BAIL REVIEW HEARING RE DEFENDANT GEORGIA DeFILIPPO

APPEARANCES:

The People of the State of California is present by Marlisa Ferreira, DDA. (Investigator Kirk Bunch is also present.)

Defendant, GEORGIA DeFILIPPO is present with Tim A. Pori, Esq.

Also present in this case are Defendant, FRANK CLIFFORD CARSON with Preciliano Martinez, Esq., Defendant, BALJIT ATHWAL by Martha Carlton-Magana, Esq. and Defendant, CHRISTINA ANNE DeFILIPPO by Ryan Roth, Esq.

(Present for other matters are Bruce Perry, Esq. for Robert Woody, a Defendant in a separate action - case No 1471110 and Stephen Schmid - attorney for Intervenor, Michael Hoyt in civil case No. 2016630.)

At 10:40 a.m., case is regularly called for hearing.

Defendant, GEORGIA DeFILIPPO'S witness, Charles Heckendorf, Jr. is sworn in and testifies.

At 10:50 a.m., People's counsel, Marlisa Ferreira conducts cross-examination.

At 11:26 a.m., Mr. Pori, Esq. conducts re-direct examination.

Defendant, GEORGIA DeFILIPPO'S Exhibit G-A is marked for identification.

At 11:37 a.m. Defendant, GEORGIA DeFILIPPO'S counsel provides oral arguments in support of bail reduction.

At 11:46 a.m. the People's counsel provides oral argument.

At 11:59 a.m. Defendant, GEORGIA DeFILIPPO'S counsel provides further argument.

Court takes the lunch recess.

At 1:35 p.m., the Court is back in session. All parties/counsel stated previously are present. (In addition, Mr. Gradford, Esq. and his client Defendant, EDUARDO QUINANTAR, JR. and Lawrence Niermeyer, Esq. and his client Defendant, SCOTT McFARLANE are present.)

Court hears continuing arguments from Defendant, GEORGIA DeFILIPPO'S counsel and Marlisa Ferreira, DDA.

Court hereby **ORDERS** that Defendant, GEORGIA DeFILIPPO'S bail is reduced to \$4,500,000.00. If Defendant is able to post bail, the following conditions must be met: She may not possess any firearms. A waiver of extradition must be signed, witnessed and notarized. Counsel must meet and confer before Friday re the form of the waiver. Her passport must be surrendered. She must stay within Stanislaus County. She may contact Stephanie Mitchell, Court Calendar Manager to arrange permission from the judge to travel to San Francisco to meet with counsel. The judge will need to know how much time is needed each time. She must have no contact with Korey Kauffman's family and stay 100 yards away from them. She must stay away from any witnesses in this case and shall not annoy or harass them. She is subject to search and seizure.

This case is **SET** for a Bail Source Hearing (*and Continued Arraignment*) on **September 25, 2015 at 9:30 a.m. in Department 26**. (Defendant, FRANK CLIFFORD CARSON has requested to be transported by the jail for this hearing, this request is **GRANTED**.) Counsel are to have the waiver of extradition for presentation to the Court by this date.

The following additional upcoming hearings are **CONFIRMED**:

September 25, 2015 at 10:00 a.m. in Department 26 for Order to Show Cause as to the Stanislaus County Sheriff's Office re Shackling and to Vacate Interim Order re Shackling;

October 1, 2015 at 10:00 a.m. in Department 26 for: 1. Defendant, BALJIT SINGH ATHWAL'S Motion to Dismiss for Outrageous Government Misconduct and 2. Defendant, BALJIT SINGH ATHWAL'S Motion to Quash Ramey Warrant.

October 1 and 2, 2015 at 10:00 a.m. in Department 26 for Motion to Recuse the Stanislaus County District Attorney's Office.

Defendant, GEORGIA DeFILIPPO is remanded to the custody of the Sheriff with bail current set at \$4,500,000.00.

This matter concludes at 2:15 p.m.
