BAIL SOURCE HEARING RE DEFENDANT, GEORGIA DeFILIPPO

APPEARANCES:

The People of the State of California is present by Marlisa Ferreira, DDA. (Investigator Kirk Bunch is also present.)

Defendant, GEORGIA DeFILIPPO is present with Tim A. Pori, Esq.

Also present in this case are Defendant, FRANK CLIFFORD CARSON with Preciliano Martinez, Esq., Defendant, SCOTT McFARLANE by Lawrence Niermeyer, Esq., Defendant, EDUARDO QUINTANAR, JR. by Lawrence Niermeyer, Esq. (specially) and Defendant, CHRISTINA ANNE DeFILIPPO with Ryan Roth, Esq.

At 9:39 a.m. this case is regularly called for hearing.

The People state that they are satisfied with the source of the funds; they are legitimate.

Defendant, GEORGIA DeFILIPPO turns her passport over to the Court. The Court marks the passport at Court's Exhibit No. 1 and **ORDERS** that this exhibit shall be sealed and stored in the Court's vault for safekeeping.

Waiver of Extradition issues are discussed. Defendant waives her rights to extradition. The Waiver of Extradition is signed and notarized.

At 9:45 a.m. Defendant, SCOTT McFARLANE'S counsel and Defendant, EDUARDO QUINTANAR, JR.'S specially appearing counsel request the preliminary examinations set for these Defendants on September 28, 2015 be continued for two weeks. both Defendants waive their ten day time period. They do not waive their 60 day time period. Court **GRANTS** this request and **ORDERS** Defendants, SCOTT McFARLANE and EDUARDO QUINTANAR, JR. to be present in **Department 26 on October 1, 2015 at 10:00 a.m.** to take their ten day time waiver in person before the Court.

The preliminary examination hearings of Defendant, EDUARDO QUINTANAR, JR. and SCOTT McFARLANE set for September 28, 2015 are hereby **VACATED**. Their preliminary examination hearings are hereby **RESET** to be heard on **October 13, 2015 at 9:30 a.m. in Department 26**. There is a three to four day estimate.

At 9:50 a.m. Defendant, CHRISTINA ANNE DeFILIPPO enters a ten day time waiver before the Court. She indicates she is not entering a 60 day time waiver.

Defendant, GEORGIA DeFILIPPO is hereby **ORDERED** to appear on **October 1, 2015 at 10:00 a.m. in Department 26** to execute a PC 977 waiver for her attorney and for continued arraignment.

Defendant, GEORGIA DeFILIPPO is remanded to the custody of the Sheriff with bail currently set at \$4,500,000.00.

Defendant, FRANK CARSON is remanded to the custody of the Sheriff with bail currently set at No Bail.
