

15 TO ALL PARTIES, THEIR ATTORNEYS AND MEMBERS OF THE PUBLIC:

16 PLEASE BE ADVISED that pursuant to *California Rule of Court 2.503 (e)* the  
17 Court has determined to allow remote electronic access to the public court records  
18 in the above-entitled case.

19 However, the Court does not have the resources and accordingly finds it is not  
20 feasible, for the Court to redact from documents submitted for filing the following  
21 information: driver license numbers; dates of birth; social security numbers; Criminal  
22 Identification and Information and National Crime Information numbers; addresses  
23 and phone numbers of parties, victims, witnesses, and court personnel; medical and  
24 psychiatric information; financial information; account numbers; and other personal  
25 identifying information.

26 Therefore, for purposes of the remote electronic record, the Court hereby  
27 orders any party who files a document containing such information to provide the  
28 Court with both an original unredacted version of the document for filing in the  
court file and a redacted version of the document.

The redacted version of the document shall plainly state on its first page

1 that it is the redacted copy.

2 This order applies only to court documents in the above case that are  
3 available by remote electronic access.

4 With respect to those documents already filed with the Court, the parties  
5 must supply the Court with redacted copies by no later than the close of business  
6 on September 11, 2015.

7 The Court hereby reserves the right to make, in its discretion, further  
8 redactions to such remote electronic access documents in order to protect the  
9 privacy interests and sensitive personal information of the parties, victims,  
10 witnesses, and court personnel. *California Rule of Court 2.503 (e)(1)(A)*.


