CODE SECTION 977**

23 and to be confronted by and cross-examine all witnesses, hereby waives the right to be present at  
24 the hearing of any motion or other proceeding in the case, including when the case is set for trial,  
25 when a continuance is ordered, when a motion to set aside the indictment or information  
26 pursuant to the provisions of the Penal Code, Section 977 and following is heard, when a motion  
27 for reduction of bail or for a personal recognizance release is heard, when a motion to reduce  
28 sentence is heard, and when questions of law are presented to or considered by the Court, and

1 modification of sentence. The undersigned Defendant hereby requests the Court to proceed  
2 during every absence of them, which the court may permit pursuant to this waiver, and hereby  
3 agree that their interest will be deemed represented at all times by the presence of their attorney  
4 the same as if the Defendant himself were personally present in court, and further agree that  
5 notice to his attorney that his presence in court on a particular day at a particular time is required  
6 will be deemed notice to them of the requirement of their appearance at said time and place.
