

15 TO ALL PARTIES, THEIR ATTORNEYS AND MEMBERS OF THE PUBLIC:

16 Due to the extraordinarily high number of requests for access to documents
17 in the above-entitled case, the Court has determined to permit remote electronic
18 access to public court records pursuant to *CRC 2.503 (e)*.

19 In making, this decision the Court has considered the privacy interests of the
20 parties, victims and witnesses, the benefits to and burdens on the parties in
21 allowing remote electronic access, including possible impacts on jury selection and
22 the burdens on the court in responding to the extraordinary high number of requests
23 for access to documents.

24 The Court will post documents at the website specified below with the exception
25 of those documents ordered sealed by the Court. The Court will post copies of all
26 pleadings filed in the case, copies of minute orders, unreported minute orders, all
27 motions and responses to motions and any exhibits thereto.

28 With respect to motions, the Court will not file copies of cases attached to
motions or to any responsive papers. However, Counsel must lodge with their papers a
cover sheet listing all cases with citation thereto.

1 Juror names or other juror identifying information will not be provided by remote
2 electronic access.

3 The Court will not post media request forms nor the Court's response these
4 requests.

5 The following information will be redacted from the remote electronic access
6 documents: driver license numbers; dates of birth; social security numbers; Criminal
7 Identification and Information and National Crime Information numbers; addresses and
8 phone numbers of parties, victims, witnesses, and court personnel; medical or
9 psychiatric information; financial information; account numbers; and other personal
identifying information.


