At the request of Ms. Belsher, the Complaint is corrected on its face to reflect the correct name of her client, Christina Ann DeFilippo.

At the request of the People, the name "Christina DeFilippo" is stricken as to Count I only.

Defendant Baljit Atwal's last name is incorrect on the Complaint. The Complaint is corrected on its face to reflect the correct spelling "Baljit Athwal".

Defendant Georgia DeFilippo's true DOB is 11/24/1951.

The motion to exclude cameras in the courtroom during the court proceedings is GRANTED.

The motion of all defense counsel to have the defendants unshackled during the court proceedings is DENIED without prejudice.

Ms. Ferreira informs the court that the People have not determined yet if they will be seeking the death penalty in this matter.

At the request of Mrs. Carlton-Magana and Mr. Hjertonsson, two Punjabi interpreters are required for Defendants Baljit Athwal and Daljit Atwal.

It is the Court's intention to set bail at 10 million as to each defendant in custody. Ms. Ferreira objects to bail being set.

Mr. Pori files in open court his motion for order limiting use of shackles for the court to review.

All defense counsel join in on Mr. Pori's motion.

The Court continues this matter to August 25, 2015 at 9:00 am in a Department to be Assigned for continued arraignment and setting of bail.

All counsel waive time on behalf of their clients with the exception of Baljit Athwal and Walter Wells, who waive time only until August 25, 2015.

Bail remains at no bail as to Defendants in custody only.

Defendants are ordered to return on the above date and are remanded to the custody of the Sheriff.
