

22 I, Daljit Atwal, do hereby state and declare:

- 24 1. I am currently incarcerated at the Stanislaus County Jail without bail.
 - 25 2. During legal visits I am restrained in a manner making it very difficult to effectively
26 communicate with my attorney and prepare my defense in this matter. I am restrained in
27 the following manner during legal visits:
 - 28 a. Leg irons chains around my ankles and a chain around my waist.
 - b. Handcuffs tightly clamped on my wrists to which a box is attached.
 - c. Handcuffs are connected to the chain around my chest.
 - d. I am chained to a short metal stool in the visiting room.
 3. These physical restraints are very uncomfortable making it very difficult to concentrate


1 on the discussion I am having with my attorney.

2 4. I cannot make any notes in writing during my conversations with my attorney based on
3 the restrains described above.

4 5. I have never been arrested before and I have been cooperative and compliant with the
5 custodial officers while being incarcerated.


