Please take notice that pursuant to California Rules of Court, rule 2.503, subdivision (e), the court will consider providing remote electronic public access to the following court records in the above-referenced case:

1. All documents currently filed with court;
2. Any document filed with court after the date of this order, including but not limited to orders, pleadings, motions, responses to motions and transcripts of proceedings. However this order shall not apply to any documents sealed by the court or made confidential by law;

1 If the court permits the remote electronic access to records, documents will be
2 redacted pursuant to Rule 2.503, subd. (e)(2), which requires, to the extent possible,
3 redaction of personal identifying information. This information includes, but is not
4 limited to, driver license numbers; dates of birth; social security numbers; Criminal
5 Identification and Information and National Crime Information numbers; addresses and
6 phone numbers of parties, victims, witnesses, and court personnel; medical or
7 psychiatric information; financial information; and, account numbers.

10 Any party or other person who files a document, which contains personal
11 identifying information, shall provide an original unredacted version for filing with the
12 court and a redacted version of the document for remote electronic access.

13 Any person may file written comments for the court to consider before the court
14 makes a determination to provide remote access to the records identified above.
15 Comments shall be filed within five days of the date of this order with the clerk of the
16 Court. To be considered, the comments must include the name and address of the
17 author. Comments will be filed and will become part of the court record.


