

# SUPERIOR COURT OF CALIFORNIA COUNTY OF STANISLAUS TRAFFIC DIVISION

Instructions for Request for Reduction of Fine and Order;
Advisement and Acknowledgement of Rights; Entry of Guilty or No Contest Plea Form

The Court is offering a <u>new program</u> that can quickly resolve your traffic citation without having to go to Court. This one-page request form gives you the ability to ask the Court to:

- 1. Significantly reduce your fine without having to attend a Traffic Court hearing;
- 2. To allow one or more violations to be corrected with documentation you send to the Court;
- 3. To request Traffic School, in addition to receiving a reduction in your fine.

### In order to be eligible for this program, the following conditions must all be met:

- 1. You have not gone to Court on this case, entered a plea and received a Court order.
- 2. Your case must be timely. "Timely" means your appearance or hearing date is very recent, or is set for a date in the future. If your case was continued due to a Court closure, you are likely timely if you haven't taken other action on it.
- 3. You cannot have a Failure to Appear DMV hold on your license due to this case.
- 4. Your case cannot be in a Failure to Pay, in collections, or on a payment plan status.
- 5. If you are a juvenile, your parent or legal guardian must sign a parental consent form to allow you to take this action.

## Steps for completing form:

- 1. <u>Read sections #3 and #4</u> on this form so you are aware of your rights, and what you will be acknowledging when you sign this form.
- 2. Read section #2, if you have a proof of correction to be considered, you must attach documentation, such as proof of insurance cards; corrections signed off by a police officer on the back of your citation, etc. If you do not want to submit proof of correction, mark the check box " I do not wish to provide proof of correction. I wish to have my fine reduced without showing proof of correction."
- 3. <u>Read section #5</u>, and look at the fine reduction amounts. If the reduced amount on the right column is more than you can pay because of financial hardship, you can ask for additional relief by filing a "Request for Order" packet, which is available on the court's website.

#### 4. Read section #6

a. Mark the box **only** if you are requesting Traffic School. Be sure it is marked if so.

### 5. Complete section #6 as follows:

a.	Signature:	Sign your name
b.	Print Name:	Print your name under the signature
c.	Driver License:	fill in your license or state ID number
d.	Date of Birth:	fill in your month, day and year of birth
e.	Date:	Fill in date you signed it
f.	Address:	Complete your mailing address, including city, state and zip code
g.	Phone:	fill in your phone or message number
h.	Email Address:	add your email address

## Send your form to Traffic Court: 2260 Floyd Avenue, Modesto, CA 95355

There is a drop box available on an outside door if you prefer to drop it off at our location.

#### **Important Information:**

- 1. Do not send money for payment until you receive a copy of your order in the mail.
- 2. The Court will let you know how much to pay.
- 3. If approved, you will have 60 days to pay your ticket, or 90 days if you take traffic school.
- 4. Payment Methods online at <a href="https://www.stanct.org">www.stanct.org</a> or by check, money order or cashier's check sent by mail or drop box.
- 5. Be sure to send any proof of corrections with your form or it will not be allowed as a correction.
- 6. If your fine is more than you are able to pay, you can file a Request for Order packet to request additional relief due to a financial hardship. Forms are on the Court's website at <a href="https://www.stanct.org">www.stanct.org</a>

#### If your request for reduction was denied:

The Court will add a page to your order, and will specify why you were denied. Review Attachment A – Additional Orders form for specific reasons. You may resubmit a new request if you were denied due to missing documentation.
